SERVICES NAVIGATOR

RESPITE SERVICES

Facility-based respite for adults with disabilities who require assistance in the absence of their family member or caregiver in St. Louis.



EMPLOYMENT SERVICES

Assists clients by identifying individual skills and interests to achieve a job of their choice in Jefferson City and St. Louis.



YOUTH PROGRAMS

(a) 8-weeks of Summer day camp available for school-aged children with a disability diagnosis living in metro St. Louis. This camp also meets one week during winter break and spring break. (b) A Summer Voucher program that provides financial assistance for St. Louis youth diagnosed with a disability to attend summer camps and recreational activities.
